Purpose:

The applicant is requesting relief to permit the construction of a new dairy barn and manure storage area which will replace the existing facilities on the property. Relief is required from Zoning By-law 40/2016 relative to Section 4.24.2 MDS II – New or Expanding Livestock Facilities to permit a new barn to be built 135m from the nearest residence whereas 167m is required, and to permit a new manure storage to be built 228m from the nearest residence whereas 250m is required.

By-law

Requirements:

The applicable portion of Zoning By-law 40/2016 states as follows:

Section 4.24.2 MDS II - New or Expanding Livestock Facilities

Notwithstanding any other *yard* or setback provisions of this By-law to the contrary, no *livestock facility* shall be *erected* or expanded unless it complies with the Minimum Distance Separation (MDS II) as may be amended, calculated using the Formulas set

out in Appendix "A" to this By-law.

The applicant is requesting relief to permit the construction of a new dairy barn and manure storage area which will replace the existing facilities on the property with the required relief as noted above.
