

NOTICE OF THE PASSING OF ZONING BY-LAW AMENDMENT BY THE CORPORATION OF THE TOWNSHIP OF GUELPH/ERAMOSA

TAKE NOTICE that the Council of the Corporation of the Township of Guelph/Eramosa passed By-law No. 55/2020, on the 5th day of October, 2020, under Section 34 of the *Planning Act*, R.S.O. Chapter P. 13, as amended.

AND TAKE NOTICE that the last date for filing a notice of appeal to the Local Planning Appeal Tribunal in respect of the by-law is the **27**th **day of October**, **2020**. A Notice of Appeal setting out the reasons for the appeal must be filed with the Clerk of the Township of Guelph/Eramosa and accompanied by the appropriate fee as required by the Local Planning Appeal Tribunal.

Note: Only individuals, corporations and public bodies may appeal a by-law to the Local Planning Appeal Tribunal. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

AN EXPLANATION of the purpose and effect of the by-law and a key map showing the lands municipally known as 5174 Seventh Line, legally known as Concession 6, Pt Lot 7, in the former Township of Eramosa, now in the Township of Guelph/Eramosa, to which the by-law applies, are shown below.

PURPOSE AND EFFECT

By-law 55/2020 amends Zoning By-law 40/2016, being Zoning By-law controlling land use development within the Township of Guelph/Eramosa. The purpose of the by-law is to amend the zoning from Agricultural (A) to Agricultural with Special Provision 21.199 (A.21.199) to prohibit the construction of a dwelling or accessory structures on the lands that are intended to be used for environmental conservation purposes, and adding environmental protection lands by amending the zoning on portion of the lands from Agricultural (A) to Environmental Protection (EP).

Public consultation of the proposal for a Zoning By-law Amendment was provided through a notice published in the newspaper dated September 10, 2020 and a public meeting held on October 5, 2020. All comments received were considered as part of the decision making process as discussed in Planning Report 20/18.
