Purpose: The applicant is requesting the following:

1. To permit minimum side yard setbacks of 2m for each side of a proposed dwelling, whereas minimum side yard setbacks of 3m are required.

2. To permit a minimum lot frontage of 13.7m, whereas a minimum of 30m is required

3. To permit a minimum lot area of 1,000m<sup>2</sup>, whereas a minimum of 4,000m<sup>2</sup> is required.

**Request:** Relief from Section 7.2.1, 7.2.2, & 7.2.5 of Zoning By-law 40/2016.
