Please take note that under Section 45(1) of the Planning Act, the Committee of Adjustment for the Township of Guelph/Eramosa will be holding a Public Hearing to consider the following application:

# SUBJECT5438 Wellington Road 26, Township of Guelph/EramosaPROPERTY:CON 7 E PT LOT 14 RP 61R719; PART 1

## **REQUESTED RELIEF:**

- 1. Relief from Section 3 of Zoning By-law 40/2016, as amended, to permit a modification to the definition of "Home Occupation Trade" to include automobile maintenance and engine repair whereas the current definition specifically excludes automobile-related uses.
- Relief from Section 4.12.3.1 of Zoning By-law 40/2016, as amended, to permit a Home Occupation

   Trade with a gross floor area of 105.91m2 (1,140ft2), whereas the maximum gross floor area is
   100m2 (1076ft2).
- Relief from Section 3 and Section 4.12.3.7 of Zoning By-law 40/2016, as amended, to allow a Home Occupation – Trade to be located within an attached garage, whereas a "Home Occupation – Trade" is to be located in an accessory building detached from the main dwelling unit.
